The Factory Direct Program is for very slow moving parts that are not stocked at distributors, and for Flash programmable units if you want a pre-programmed unit (RR200 charge applies). If a part is listed as a factory Direct, call or e-mail and check for availability first.

**Do NOT send your unit in for R&R if a Factory Direct is available. Call or e-mail us for availability.**

If a Factory Direct unit is returned with Option 1 checked on the R&R form, we WILL rebuild and return the original unit. Billing will be at the **HIGHER** of either the unit or R&R pricing.

If the original unit contained a knock sensor module, please remove for reuse. We DO NOT ship Factory Direct with knock sensor modules.

## Return & Rebuild (R&R) Program

Before sending in a unit for R&R, please check our Factory Direct program listed above. We may be able to ship a unit today.

All computers sent in for R&R will be tested upon receipt. If the unit tests good, we will call the customer and ask how to proceed.

**IMPORTANT: DESPITE OUR BEST INTENTIONS AND EFFORTS, NOT ALL UNITS ARE REBUILDABLE DUE TO WATER DAMAGE, EXCESSIVE VOLTAGE THAT HAS DESTROYED THE BOARD AND OTHER REASONS.**

If we are unable to rebuild your unit we will call and ask you how to proceed. A \$5 handling fee applies (NR100).

WE MAY OR MAY NOT HAVE ANOTHER UNIT THAT CAN REPLACE THE UNIT YOU SEND US.

If the unit tests good and we are unable to contact the customer, either because no answer or the form is not completed properly, we will surface clean the unit to remove grease and dirt, return and bill just for testing. We will show that the unit tested good.

Checking Option 1 means your original unit will be rebuilt and returned to you.

If it is not specified how to ship the unit back, we will ship it back Regular Ground Delivery. All return freight charges are billed to the customer.

All mounting brackets must be removed. We are not responsible for broken or missing brackets.

## ECM "Flash" Reprogramming

"Flash" Reprogramming is available at many automotive service providers and distributors. Check with your distributor for a local provider and the fastest service.

If local service is not available, use this form to return a unit for programming (RR200).
